If you wish to eFile in the Travis County District Courts, please select **Travis County** rather than Austin County.

Did You Know?

You need to register only once with TexasOnline eFiling for Courts

Registering with any of our eight certified Electronic Filing Service Providers automatically registers you with TexasOnline.

If you choose to change service providers, you can retain your original user name and password. You will still have access to all eService you received prior to changing providers. However, any eFilings you submitted prior to the change will be viewable only through the original service provider from which they were submitted.

Question

How can I confirm that electronic service was completed?

Answer

To verify that the electronic service has been sent to the recipient, log on to your service provider account and view the transaction in the electronic service outbox. A status of "notified" indicates that the recipient has been sent the required notice.

Question

Can proof of service email notifications be sent to more than one address?

Answer

Your service provider may send messages to more than one email address. You may also elect to use a shared email account or to redirect selected messages to more than one email address.

Question

Can sealed documents be electronically filed?

Answer

Rule 3.3 prohibits electronic filing of documents sealed pursuant to Texas Rule of Civil Procedure 76a. A motion to have a document sealed, as well as a response to the motion, may be filed electronically.

Question

What governs the use of cover letters and cover sheets?

Answer

The general guidance is that your lead document should always be the one you want to receive the file-stamp. Therefore, a cover letter is usually added as an attachment so that it is not file-stamped.

As an exception, when you are submitting a proposed order, the cover letter should be the lead document so that the proposed order is not file-stamped.

Cover sheets are required as attachments to petitions in selected jurisdictions, including Dallas District Civil and Family (see www.dallascounty.org/department/districtclerk/districtclerk_guidelines.html).

Filer Tips

You may attach only **One Primary Document** per eFiling submission

- Attaching multiple documents that require a file stamp to the same filing may result in a rejected filing. Remember, the lead document will receive the file stamp.
